CIRCULAR

Sub: Processing of Distributed Solar Photovoltaic (DSPV)/Solar Rooftop PV (SRTPV) applications and execution of Consent/Power Purchase Agreement (PPA) for applications registered on or after 01.07.2026 - Reg.

Ref: KERC Order for "Determination of tariff in respect of Solar Power Projects (Including Distributed Solar Photo Voltaic plants (DSPV) for a period from 01.04.2025 to 30.06.2026" dated:09.07.2025

The Hon'ble Karnataka Electricity Regulatory Commission (KERC), in exercise of its powers under the Electricity Act, 2003, determines the tariff and other commercial terms applicable to Distributed Solar Photovoltaic (DSPV)/Solar Rooftop PV (SRTPV) projects from time to time.

The tariff determined by the Hon'ble Commission vide Order dated 09.07.2025 was applicable only to the Power Purchase Agreements (PPAs)/Consents executed during the control period 01.04.2025 to 30.06.2026.

The said control period has expired on 30.06.2026. The Hon'ble Commission is presently in the process of determining the tariff and other applicable terms for the next control period commencing from 01.07.2026.

Pending issuance of the tariff order by the Hon'ble KERC, it has been decided that all eligible DSPV/SRTPV applications registered on or after 01.07.2026 shall continue to be processed without delay. However, the execution of the Consent/Power Purchase Agreement (PPA) shall be subject to the following conditions:

1. Clause 6.1(a) of the Standard Power Purchase Agreement shall be substituted with the following:

6.1 (a) The ...ESCOM shall pay for the net energy/gross energy (as the case may be) at the tariff that may be determined by Hon'ble Karnataka Electricity Regulatory Commission (KERC) for the control period commencing from

01.07.2026, as amended or modified from time to time, and the Parties shall be bound by such tariff order and all conditions specified therein."

2. Wherever the Standard Consent/PPA refers to the earlier KERC Tariff Order, the same shall be replaced with the following:

"The tariff and other applicable commercial terms shall be governed by the tariff order to be issued by the Hon'ble Karnataka Electricity Regulatory Commission (KERC) for the control period commencing from 01.07.2026 and any amendments or modifications issued thereto from time to time."

3. The applicant shall furnish an undertaking/declaration stating that:

"I hereby agree that the tariff applicable to this project shall be the tariff determined by the Hon'ble Karnataka Electricity Regulatory Commission (KERC) for the control period commencing from 01.07.2026 and shall abide by all the terms and conditions specified in the new tariff order or Regulations issued from time to time."

4. Other conditions for field officers:

- a) Necessary modifications are incorporated in the Consent format in the DSPV portal applicable to the consumer categories where execution of a formal PPA has been dispensed with.
- b) Under no circumstances shall the expired tariff determined vide KERC Order dated 09.07.2025 (valid only up to 30.06.2026) be applied to any application registered on or after 01.07.2026.
- c) After the Hon'ble KERC issues the tariff order for the control period commencing from 01.07.2026, all PPAs/Consents shall be governed by the tariff and conditions specified therein. Wherever necessary, supplementary agreements/endorsements shall be executed to bring the existing PPAs/Consents in conformity with the KERC tariff order.
- d) Field Officers shall ensure that applicants are informed that execution of the Consent/PPA does not confer any right to claim the tariff applicable under the previous control period and that the tariff determined by the Hon'ble KERC for the new control period shall be final and binding.
